


Conducted Six Policy Dialogues Since 2008

- > Mental Health: Delinquency and Criminal Activity (February 2009)
- > Reducing Gaps in Health (September 2009)
- > Recognizing and Exploring Positive Mental Health (May 2010)
- > Sharing Knowledge—Building Links—Advancing Research, Policy and Practice on the Built Environment (March 2011)
- Measuring Health System Efficiency Stakeholder Dialogue (November 2011)

How Did We Engage Participants?

- > Approximately 50 participants with broad representation
- > Pre- and post-dialogue questionnaires
- > Group discussion for a common understanding
- > Panel presentations with discussion forum
- > Visioning exercise and group work around identifying practical and realistic actions





Findings—Discussion Forum

- > Context, determinants and equity matter
- > Capacity- and relationship-building matter
- > Evidence and evaluation matter

Policy Dialogue

- > Create an opportunity for knowledge transfer, exchange and application
 - Share findings and experiences
 - Encourage collaboration
 - Identify priority actions
- > First Day—Consult with experts on the concept of health equity and to identify additional interventions
- > Second Day—Dedicated to group work and plenary sessions to identify, develop and refine actions





Policy Dialogue

- > Four common actions:
 - Ensure leadership
 - Create a clear and coordinated plan
 - Synthesize current research
 - Profile potential action





Common Findings Across All Dialogues and Workshops

- >Increasing access to information
- > Supporting collaboration and partnerships
- >Encouraging a role for everyone
- >Valuing holistic strength-based approaches
- > Aligning activities across governments and sectors
- >Addressing basic needs and creating supportive environments
